Reason: The tree is causing some cracking in the plaster and brickwork in and around the rear extension of the property. The removal is being requested by the building insurance company.

Front Garden:

T2: Multi-stemmed Shrub: Remove including root ball.

Reason: To stop potential damage to the building.
