2018-5982P	[REDACTED]	02/06/2019 19:41:19	OBJ	<p>I object to the following aspect of the planning application:</p> <ul style="list-style-type: none"><li>- Side elevation (facing Number 7): This will directly overlook Number 7 and invade our privacy. This will enable people to look into the velux of the top floor bathroom.</li><li>- Diesel generator: the sheer dimension of the work and the excavation proposed will generate massive pollution over a very long period. We object to the use of a diesel generator to excavate, two family members being severely asthmatic and undergoing treatment for their conditions. The two bedrooms facing the street are where the two asthmatic persons sleep, having a diesel generator just underneath the windows would undoubtedly create a massive health hazard, and would force us to move home. The single glazed sash windows dont stop fumes from getting into the house, as proven by the fact that when people in the neighbouring allotments burn their rubbish, the smoke gets into our house and triggers asthma attacks.</li><li>- Excavation 4m deep to the front up to the limit of the property: The silver birch currently growing in front of our house and number 9 is extremely close to the property limit, and its roots will undoubtedly suffer from said work. That tree currently shields the master bedroom from an overlook from houses across the street.</li><li>- Upper ground floor terrace facing garden: This will generate a massive overlook onto our kitchen, being at the exact level of a very large window that covers the roof and the upper side of our extension. From our kitchen, we cant see number 9, the glass being frosted on the bottom part of the window, we can only see the sky at the moment, but from the terrace they will see everything that happens in our kitchen. Moreover, they will have an overlook onto our garden and this will invade our privacy. If a wall were to be built alongside that terrace to shield the view into our kitchen, this will take away all the light that comes from the side window. We totally oppose that terrace being built.</li></ul>
