Reason: Major limbs are extremely heavy and likely to pose an increasing hazard as the tree decays.

Front Garden:

T2: Laburnum - (left hand boundary): Fell to ground level and treat with systemic herbicide.

Reason: This tree is in a state of partial collapse with one large limb split out and overhanging the neighbouring property.
