e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Holm Oak: heavily overhanging from No.66. Reduce overhanging section in height, lateral and sub lateral growth by means of reducing overhanging branches back into the main crown structure. Raise low crown over stonework by 1.00m and raise remaining crown by 1.00-1.50m.

Reason: General maintenance whilst preserving a suitable amount of furnishing growth to maintain screen & reasonable crown density.

T2: Robinia:

Located within No.64. Thin crown density by 20%. Remove dead wood.

Reason: General maintenance.

T3: Horse Chestnut: Located in No.62 on a shared boundary with No.64. Thin crown density throughout by approximately 25-30%. Remove dead wood and broken branches. Remove decaying (previous) pollard points if found to be unsound.

T4: Robinia: Overhanging from No.66 and is situated to the rear of T2. Thin overhanging section by 20% and remove dead wood.
