Front Garden:

T1: Purple Plum: Approximately 7.00-8.00m. Prune back torn out stub to suitable and south growth point. Remove dead wood and broken branches throughout crown. Reduce weight burden and wind sail area of the lower limbs by means of reducing by 25%. Reduce remaining crown by 20%. Thin crown density (lower epicormic growth) by 20%.

T2: Purple Plum:

Approximately 7.00-8.00m. Remove dead wood. Reduce crown by 15-20%. Thin crown density by 15%.

Rear Garden:

T3: Walnut: Reduce crown by up to 20%. Raise crown by 1.00m to clear the rear wall/building. Remove dead wood throughout and crown thin by up to 15%.

T4: Acer: remove dead wood throughout the crown

Reasons: General maintenance to help reduce hazard potential and help manage the trees at reasonable dimensions for their location.
