Whether they use bicycles or mopeds, deliveroo will continue to ride across the pavement, park numerous ¿bikes¿ on the payment as they do every single day (yesterday there were 11 mopeds and drivers parked on or around the pavement) and even if they use bycycles, pedestrians will continue to be at risk of their constant pavement mounting and drivers ¿hanging around¿ for hours on end. We already have a big problem on Belsize Road with e-bikes being abandoned and o cannot imagine how much worse this will get if Deliveroo riders finish a shift and abandon their bikes.  Deliveroo do not care about us residents. They have arrogantly flouted the planning laws from start to now. They haven¿t listened to us.
