We are writing to register our objections, for a second time, in relation to the above planning application to convert the Hampstead Police Station to a Free School to be known as the Abacus Belsize Primary School.

As residents of Hampstead Hill Gardens we do not believe that the Police Station on Rosslyn Hill is the right location for this Primary School. There are already plenty of Primary Schools in the Hampstead and Belsize Park area, indeed research indicates that there are already over 650 more primary school places than needed so it is questionable why this school is needed at all.

The cost of the proposed project is exorbitant. It will be the most expensive primary school ever built in the United Kingdom and in the current financial climate of austerity measures, one really has to question where the funding for this Free School is coming from.

We are also very concerned to discover that the children who will attend this school will not be drawn from the Hampstead Catchment area. The Abacus Belsize website indicates that the school will be EXCLUDING Hampstead Children.

We remain very concerned about the increase in traffic on our already congested road. There is a primary school on Pond Street at one end of Hampstead Hill Gardens and the traffic problems early in the morning and at pick up time in the afternoon is already horrendous. By introducing this Free School on Rosslyn Hill, you will guarantee that we we will have heavy congestion on both ends of our street. We have noted that the school is suggesting that parents will be bringing their children to school by public transport but we all know that this is an unrealistic expectation and that there will definitely be a major increase in traffic to the area.

We are also very concerned about noise pollution. The current building will need to be dramatically altered to provide suitable facilities for a Primary School and it has very restricted outdoor space. The noise levels of several hundred children at playtime is going to make a major impact on what is currently a very quiet residential street.

We very much hope that the Camden Planning authority will take into account the considerable level of objection that this proposal has generated and ask the developers of the Abacus Free School project to think again and locate the school in a site that is closer to the catchment area it has designated itself to support and to find a site that will be more suitable and less costly to refurbish.
