T2 - Whitebeam - 30% crown reduction, representing 1.5 to 2m to be removed from each branch back to suitable points of strong growth, tree dimensions to change from 10m tall by 6m wide to 8m tall by 4m wide, ensure crown lifted to 3.5m due to Anti-Social Behaviour and light issues.

T3 - Holm Oak - Fell, proximity to the building is unsustainable.
