The Council has considered your application and decided to grant permission subject to the following condition(s):

## Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the

immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

The door frames of the extension hereby approved shall be timber as shown on drawing number B-18-51-1 Rev. A.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: B-18-51-2 Rev. A, B-18-51-1 Rev. A, Site Location Plan.

Reason: For the avoidance of doubt and in the interest of proper planning.

## Informative(s):

1 Reasons for granting permission

The proposed single storey rear infill extension is subordinate in scale and location to the host building, and respects the character and setting of neighbouring buildings. The doors of the extension would be appropriate in scale, number and siting to the rear elevation and would be timber framed .

The proposed infill extension would be in line with the existing rear building line and 3.4m high. The extension would adjoin a similar infill at the neighbouring dwelling and as such, it would not harm the amenity of any adjoining residential occupiers in terms of the loss of natural light, outlook, privacy, light spill or added sense of enclosure.

There are many examples of extensions in the area that are larger and project beyond the rear wall of the closet wing. As such, the proposed extension is modest in scale and would not adversely affect the wider character of the area.

No objections were received prior to making this decision. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1 and D1 of the Camden Local Plan 2017. The proposal also accords with Policy 2 of the Fortune Green & West Hampstead Neighbourhood Plan, the London Plan 2016 and the National Planning Policy Framework 2019.
