Crown reduce spread to balance by 25% to reduce encroachment to lawn

T2, T8 & T9: Maintenance works in line with good Arboricultural practice

T13: Maple - Cut the entire tree to ground level
This tree has been poorly reduced in the past and has a limited lifespan
