St Pancras Parish Church is located on Euston Road and close to an area of deficiency for access to nature and open space. This is not helped by the loss of local open space due to construction of HS2. The proposal is to make improvements to the south side of the Church gardens to make them a more welcoming, accessible and relaxing place to visit.

With the permanent closure of St James's Gardens, the closure for over 17 years of Euston Square Gardens, and the felling of over 200 trees, the Euston area is undergoing an enormous amount of change. This project aims to transform the space into a valued community garden with a variety of planting and landscaped seating areas to help build relationships within the diverse local community and provide a tranquil resting place, increase biodiversity and to improve opportunities for volunteer gardening.
