T1 - Sycamore - Do not Reduce height. Remove Ivy from the main stem - Crown thin by 25% and remove dead wood over 2" in diameter. Raise Crown removing approx 6 lowest branches of no more than 2" in diameter to allow more light under the tree. Reduce any over extended lateral branches by upto 1.5m to balance crown if needed.

The Purpose of this work is to try and get more light into the gardens through subtle pruning works
