				 The proposed new building is too large and tall for the site. It will be notably larger than others in the vicinity and the top floors and plant areas will be visible from a number of surrounding streets. If the development is to go ahead, it should be at least one storey lower. The new building looks very ugly even on paper. It will be a cheap, generic box - it does not reference anything else in Camden. It is not suitable modern architecture for a High Street. The prefabricated wall panels look cheap and the dull block colour will be ugly. The design and colour of the windows is horrible. The proposed entrance in Delancey St will cause unacceptable levels of congestion. Particularly if a 2-way cycle route is ever installed in Delancey St. Ubers and taxis dropping off and collecting hotel guests will block the single lane road - which among other things is a bus route. The entrance should be on the High Street where there are 3 lanes of traffic and a loading bay. The proposed service access is totally unsuitable - having vehicles turning in and out of this yard will be extremely dangerous - particularly if the cycle route is installed. It is suggested that vehicles will reverse into the yard, which sounds ridiculous. This is a particular concern to me. When the planning authority visits the site, I would invite them to imagine a van or lorry attempting to reverse into the site, given the volumes of fast-flowing traffic that will inevitably be driving right behind it. Delancey St is a busy road and use of the yard area as a service yard will cause choas. I have seen the congestion which Premier Inn lorries cause in Ornan Road, Hampstead. And they do not have to reverse into such a ridiculously small area. I also do not believe the assertion that Premier Inn will only use small vehicles for deliveries. They show absolutely no respect for the residents of Ornan Road, frequently blocking it for 5 minutes at the time with lorries which are far too large for the st
				In short, it is clear that Premier Inn are only interested in building a cheap box containing as many square metres of lettable room space as possible.
				It is well known that Premier Inn have a planning team to push through speculative unpopular applications of this nature. But this scheme is plainly unacceptable and I would urge Camden to reject it.
