### HOXTON HOTEL, 199-206 HIGH HOLBORN, LONDON, WC1V 7BD – DISCHARGE OF CONDITIONS APPLICATION

On behalf of our client, The Hoxton (Holborn) Limited, we submit an application to discharge condition 5, in relation to planning consent granted under 2017/0200/P at the above address.

In addition to this cover letter, the application comprises:

- Completed and signed planning application form, prepared by Indigo Planning; and
- Drawing package, prepared by EPR architects.

Planning permission was granted 25th January 2018 (LPA ref. 2017/0200/P) for:

Erection of 6 storey extension to the Newton Street wing above existing service yard, incorporating a living wall and a roof extension above existing Newton Street wing to accommodate 46 additional hotel rooms (C1).

### **Discharge of conditions**

The application seeks to discharge the following condition.

### Condition 5

Condition 5 of the decision notice states:

Samples panels of all facing materials shall be submitted to and approved in writing by the Local Planning Authority before work on the relevant parts of the development is begun. A samples board of the approved materials shall be erected and maintained on site throughout the works period and the relevant parts of the works shall not be carried out otherwise in

accordance with the details thus approved.

### Reason:

To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the Camden Local Plan 2017.

### Justification

In support of this application, we hereby submit the drawing package prepared by EPR architects to satisfy condition 5. The materials do not vary much from the approved materials under application ref. 2017/0200/P, with the main alteration the material proposed for the metal cladding and roof system as identified in **bold**. The table below sets out the approved and proposed materials.
