To date this has not happened and I have not received documents relating to this which I asked for.</p> <p>We have a lot of biodiversity in the garden and the cherry tree shielded us from the building (Lacon House) that has been rebuilt closer and higher since we moved in, especially from the exhaust fumes, delivery vans and the extractor fans.</p> <p>Chopping the remaining trees down will mean we will have no birds in our garden and no protection from the CO2 emissions and extractors. We have already lost a lot of birds that had been present for years.</p> <p>As for the antisocial behavior, this is mainly found in the archway between 13 and 14 Dombey Street and in the car park at the back, where drug dealing and taking is quite blatant.
