Species: Robinia pseudoacacia root growth (False Acacia)
Position: Rear garden
Reason: Obstruction
Cut down the above root growth.
Drill the cambium layer every 10cm around diameter and supply and insert into stump/s to prevent regrowth, to B.S.3998:21.2 the following:
Ammonium Sulphate Stump Killer.
