T1 = Large CHESTNUT - Crown thin by 20% removing major deadwood + trunk growth.

T2 = Medium LAUREL - Crown reduce height by 1m, selectively reduce lateral branches by 1m to form a neater specimen.

T3 = Small HAWTHORN - NO ACTION REQUIRED.

T4 = Medium PURPLE PLUM - Crown reduce height by 1.5-2m, selectively reduce lateral branches by 0.5-1m to form a neater specimen.

T5 = Medium SILVER BIRCH - Sever and remove as much as practically possible creeper growing within canopy.

T6 = Small SHRUB - Lightly trim to form a neater specimen.

T7 = Small SHRUB - Retrim regrowth only to form a neater specimen.
