# PLANNING (LISTED BUILDINGS AND CONSERVATION AREAS) ACT 1990 (AS AMENDED)

#### LISTED BUILDING ENFORCEMENT NOTICE

### ISSUED BY: THE LONDON BOROUGH OF CAMDEN

1. THIS IS A FORMAL NOTICE which is issued by the Council being the Local Planning Authority for the purposes of Section 38 of the above Act because it appears to them that there has been a contravention of Section 8 of the Act, in respect of the building within a conservation area described below. The Council considers it necessary to issue this notice for the reasons set out in paragraph 4 below.

#### 2. THE LISTED BUILDING

Land at: 15 GROVE TERRACE, LONDON NW5 1PH as shown outlined in black on the attached plan ("the Property").

#### 3. THE CONTRAVENTION ALLEGED

Without listed building consent: Unauthorised alteration to a Grade II\* listed building through the painting of large white letters on to the front, slate roof slope

## 4. REASONS FOR ISSUING THIS NOTICE

- a) The work outlined above has been carried out to this Grade II listed building without the benefit of Listed Building Consent.
- b) The white painted letters result in visual harm to the special architectural and historic character of the property and wider terrace, all of which is listed Grade II\*, by reason of its bright colour and incongruous appearance and is therefore contrary to policy D2 (Heritage) of Camden Local Plan 2017 and advice in Camden Planning Guidance (Design) 2019.

#### 5. WHAT YOU ARE REQUIRED TO DO

Within a period of **TWO (2) months** of the Notice taking effect:

- 1. Permanently remove all white paint from the front slope of the slate roof;
- 2. Make good any damage including restoring slates to original colour.

## 6. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 17 September 2019 unless an appeal is made against it beforehand.
