e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Rear Garden:

T1: Magnolia: Reduce crown by 15% (lateral and sub lateral growth). Remove broken branches.

T2: Located nearest to the house. Thin crown density by 15%. Reduce extraneous branches back into the main crown structure. Remove dead wood.

T3: Birch: Located on the rear boundary. Reduce overhanging section of the tree by 25%. Reduce remaining by 15-20%. Thin crown density by 20%.

Reasons: Encroaching onto neighbouring property by 1.50-2.00m and also overshadows an Irish Yew tree to the right.

G1: Row of Magnolia Grandiflora: Reduce height of group by approximately 20%.

S1: Griselinia: Reduce back to previous reduction points. Trim to tidy and control encroachment towards Bay.

T4: Large Bay: Reduce crown by up to 25% as is practicable whilst preserving suitable viable growth points.

T5: Small Bay: Reduce back to previous reduction points.

T6: Cherry: Thin crown density by 20%. Reduce lateral and sub lateral branches by 20-25%.

G2: Photinia in Bamboo Group: Reduce by up to 1.00m.

Reasons: General maintenance unless otherwise specified.
