T2: Apple: This tree is dead. Remove the dead leading branch and retain main stem for aesthetic value.

T3: Juniper: Reduce the lower section of the crown by up to approximately 5.00m above ground level.

G1: Yew - (clipped hedging): Adjacent to the main lawn. Trim top section by approximately 30cm to tidy.

Reasons: General maintenance unless otherwise specified.
