T7 - Lime - 13 Woodchurch Road (playground area) Fell  
T8 - Ash - Sidney Boyd Court (off site to south) Fell  
T9 - Ash - Sidney Boyd Court (off site to south) Fell  
T10 - Ash - Sidney Boyd Court (off site to south) Fell  
T11 - Holly Ornamental evergreen in raised planter - 13 Woodchurch Road (rear) - Fell
