Rear Garden:

T1: Evergreen Oak: Approximately 7.00m. Reduce crown by approximately 20% to form a smaller more compact crown.

T3: Lime: Approximately 13.00-14.00m. Reduce back to previous most recent reduction points (approximately 20-25%). Remove dead wood & Ivy.

G1: Group/Row of Leyland Cypress: Approximately 7.00m. Reduce back to a more dense hedge line approximately 25%. Reason: These trees have become thin with extended branch structure, partially due to low light levels caused by Lime & Cherry trees growing within close proximity.

T5: Holly: approximately 6.00m. Reduce crown by 15-20%.

T6: Cotoneaster: Located in No.5 but overhangs No.3A. Approximately 4.50m. Reduce overhanging section by 15-20% to control encroachment.

Reasons: General maintenance unless otherwise specified.
