The proposed works consist of the installation of 12No. new antennas, 4No. 300mm dishes, 5No. cabinets and ancillary works thereto.

Telefónica UK Limited has entered into an agreement with Vodafone Limited pursuant to which the two companies plan to jointly operate and manage a single network grid across the UK.
