and all have been excellent neighbours. We developed personal relationships with The London Ecology Centre, a pet shop, Snappy Snaps and Adolfo Dominguez, handling out of hours problems for them and happily using their services.

I am not objecting to the shop, I am objecting to the type of shop.

Tesco fills us with dread. Their Metro shop on Garrick Street and New Row is permanently cluttered and messy from their huge delivery lorries and the rubbish from packaging. Endell Street has no capacity for large delivery trucks, which currently use the single line loading area on Shelton Street, past Neal Street, 150 meters away.

There is no side or back entrance, all shop amenities open into the street. Endell Street has two dedicated disabled parking bays by the corner, then a single resident's bay and then a small loading bay, which is in use throughout the day for the Cross Keys pub. Circus nightclub and all the shops and restaurants in the areas. It can't comment on the effect it will have on traffic until we see what the West End Project does to Endell Street but as it is now, our corner is cluttered all day long with lornes and rubbish vehicles coming from the Westminster side. The West End Project will also make approaching and turning into Endell Street much more difficult than at present.

Where are they going to store and dispose of their rubbish? I've asked for a presentation by Tesco to the local community and was advised that because of the holidays it couldn't be considered until September.

I am most concerned about the anti-social aspect of Tesco coming in. I believe it will be a magnet for the street and night people in our area, as it is in the New Row shop. Residents in our 9 flats struggled this last winter with people breaking in and sleeping in our common parts at least twice a week. Drugs paraphernalia, open sexual acts, food scraps have all been left behind. The police have been very supportive but until winter comes we won't know whether this problem has been solved.

There are no chain stores or restaurants on Endell Street.
