

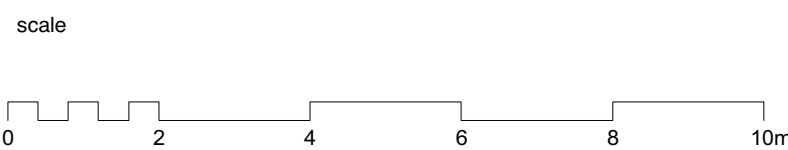

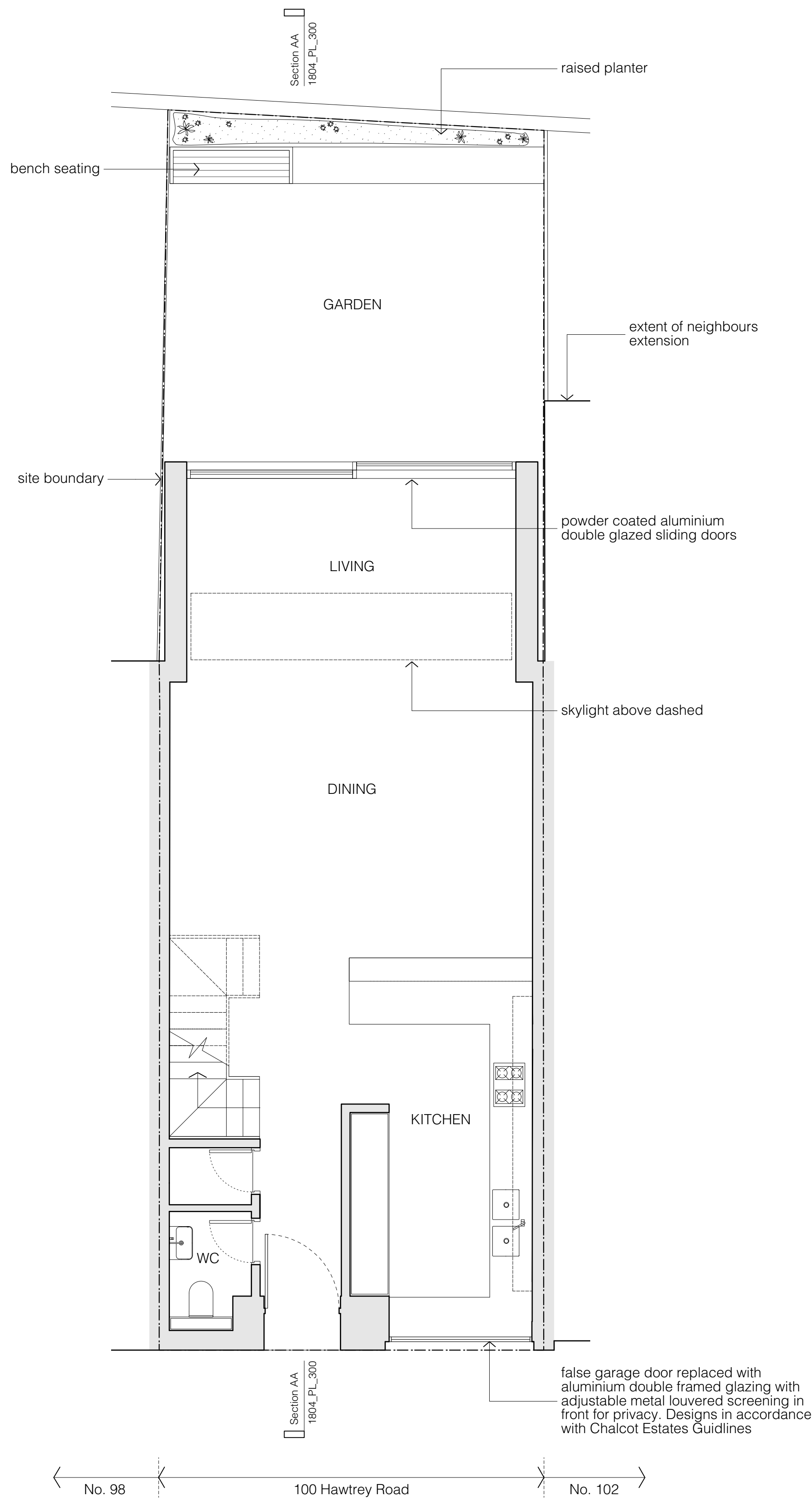

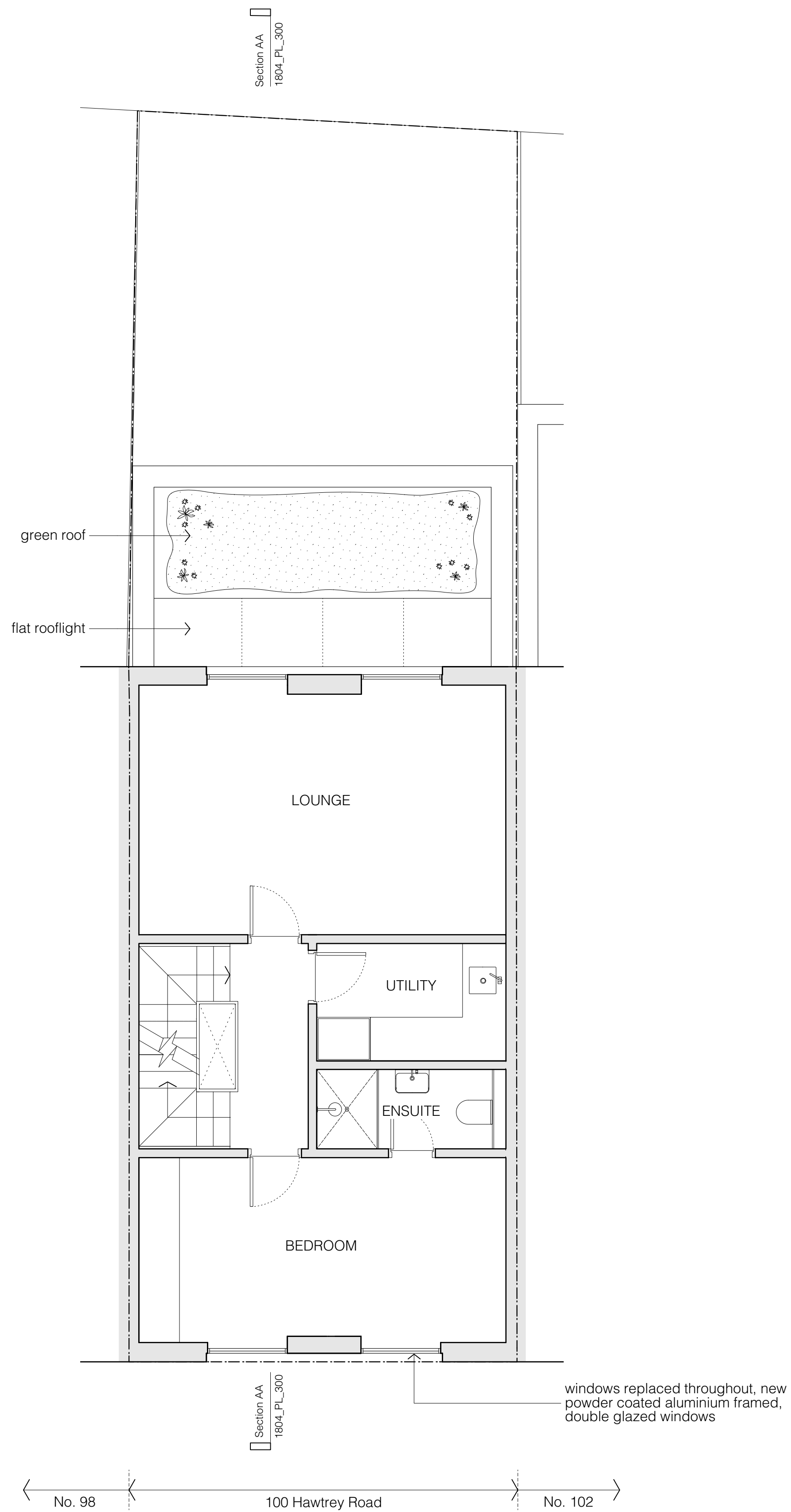

Proposed First Floor Plan

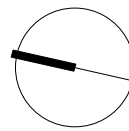

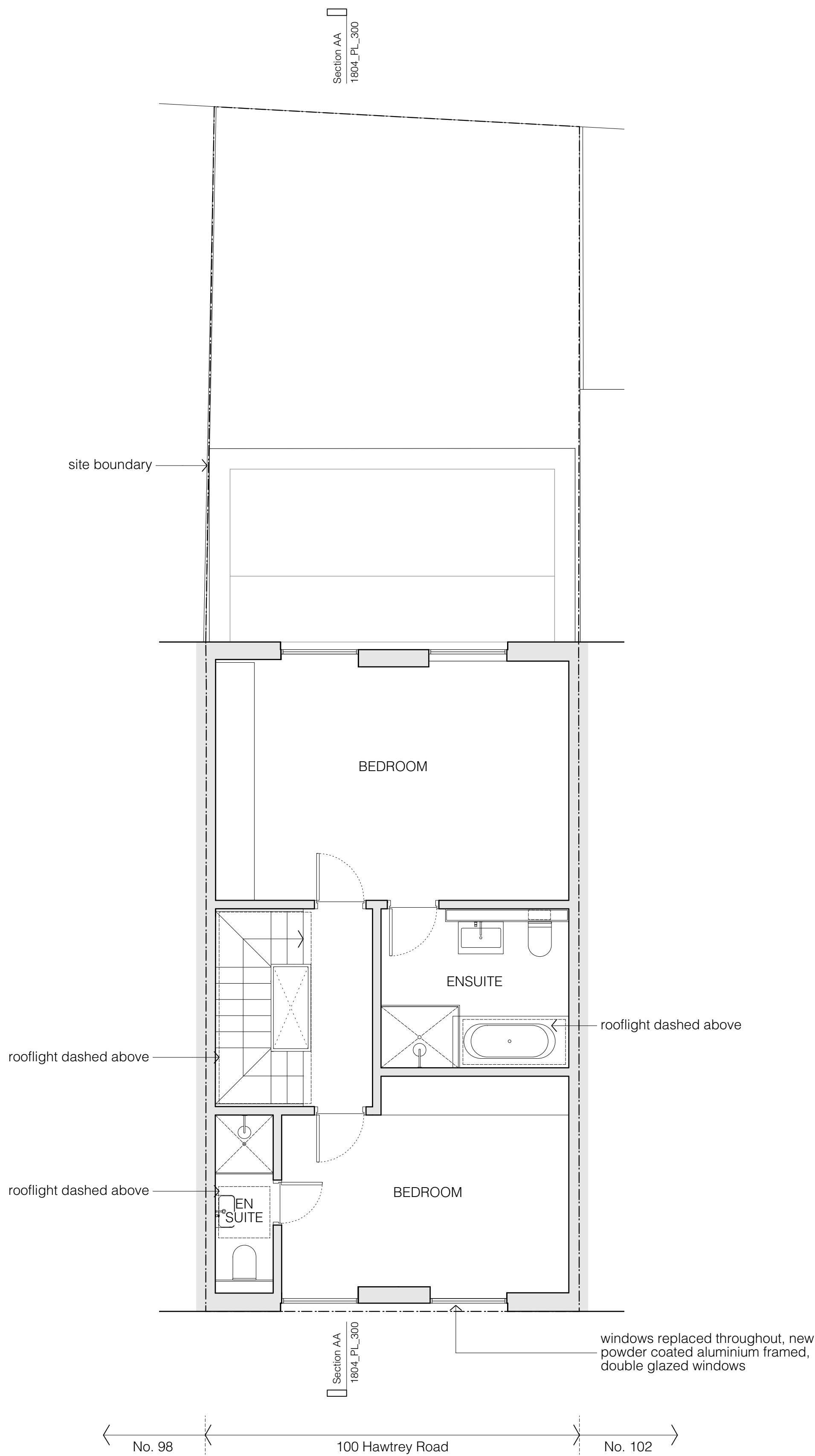

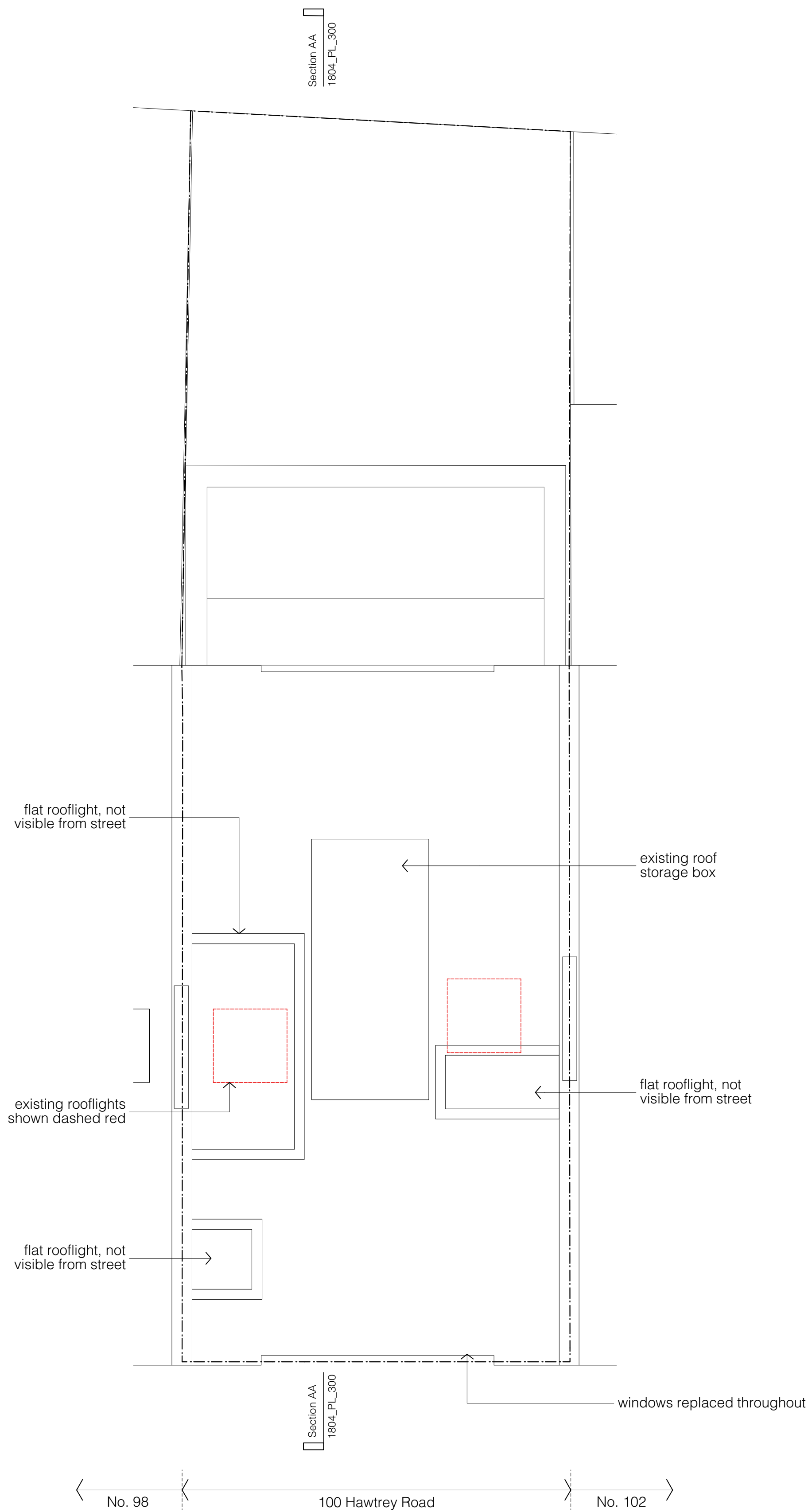

Proposed Roof Plan

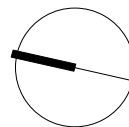

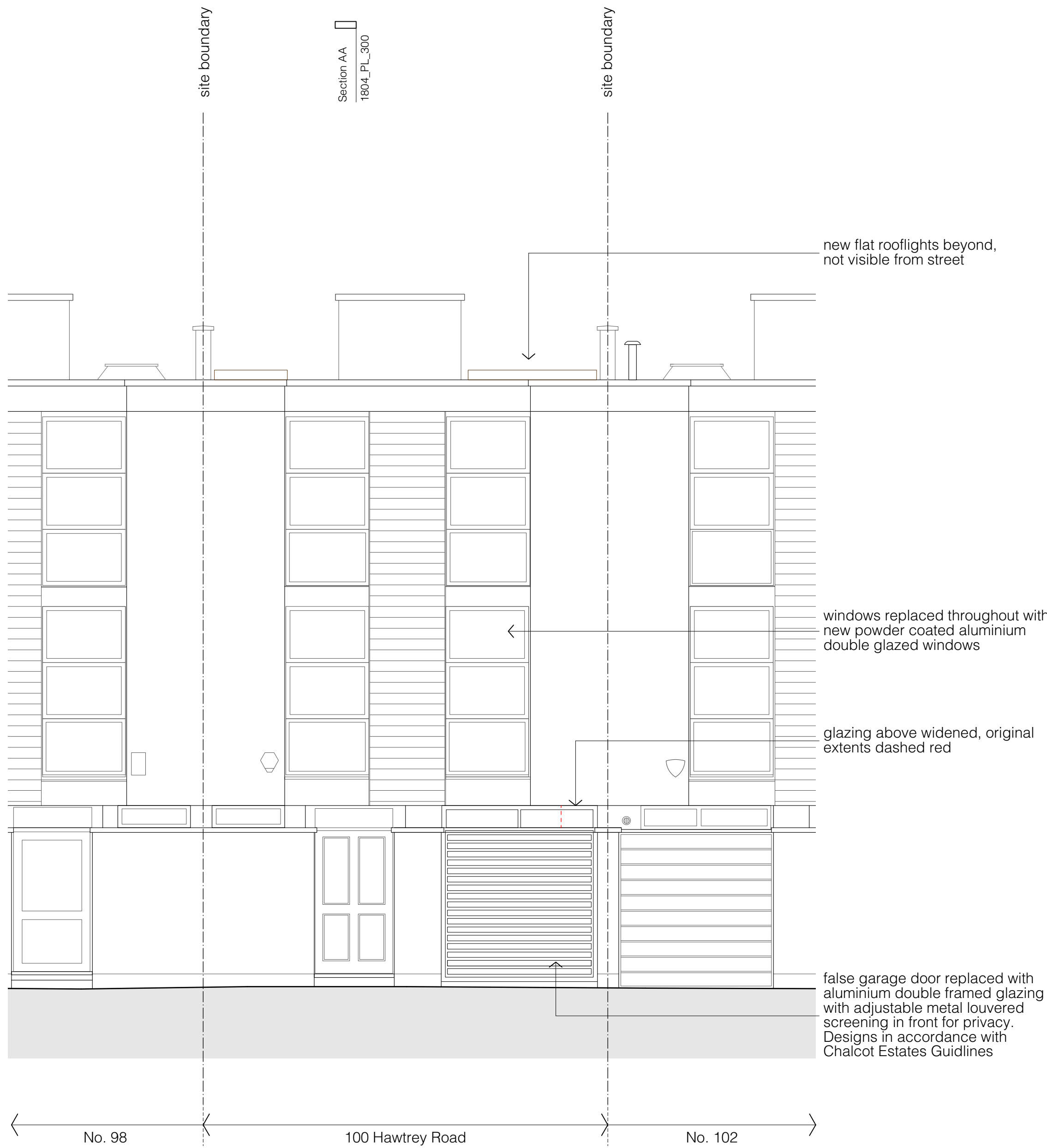

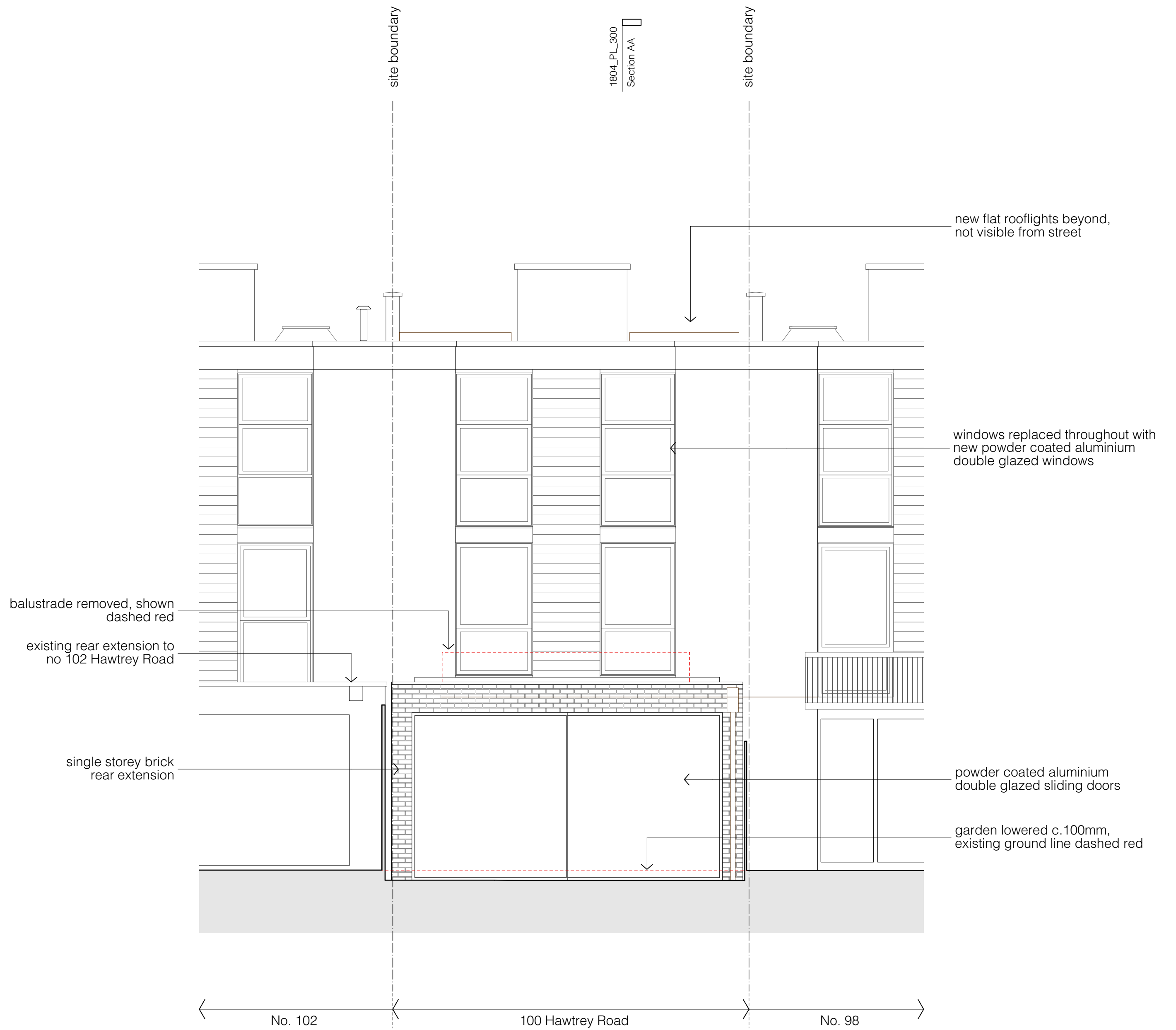

Proposed Front Elevation



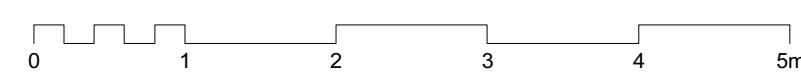
Proposed Rear Elevation

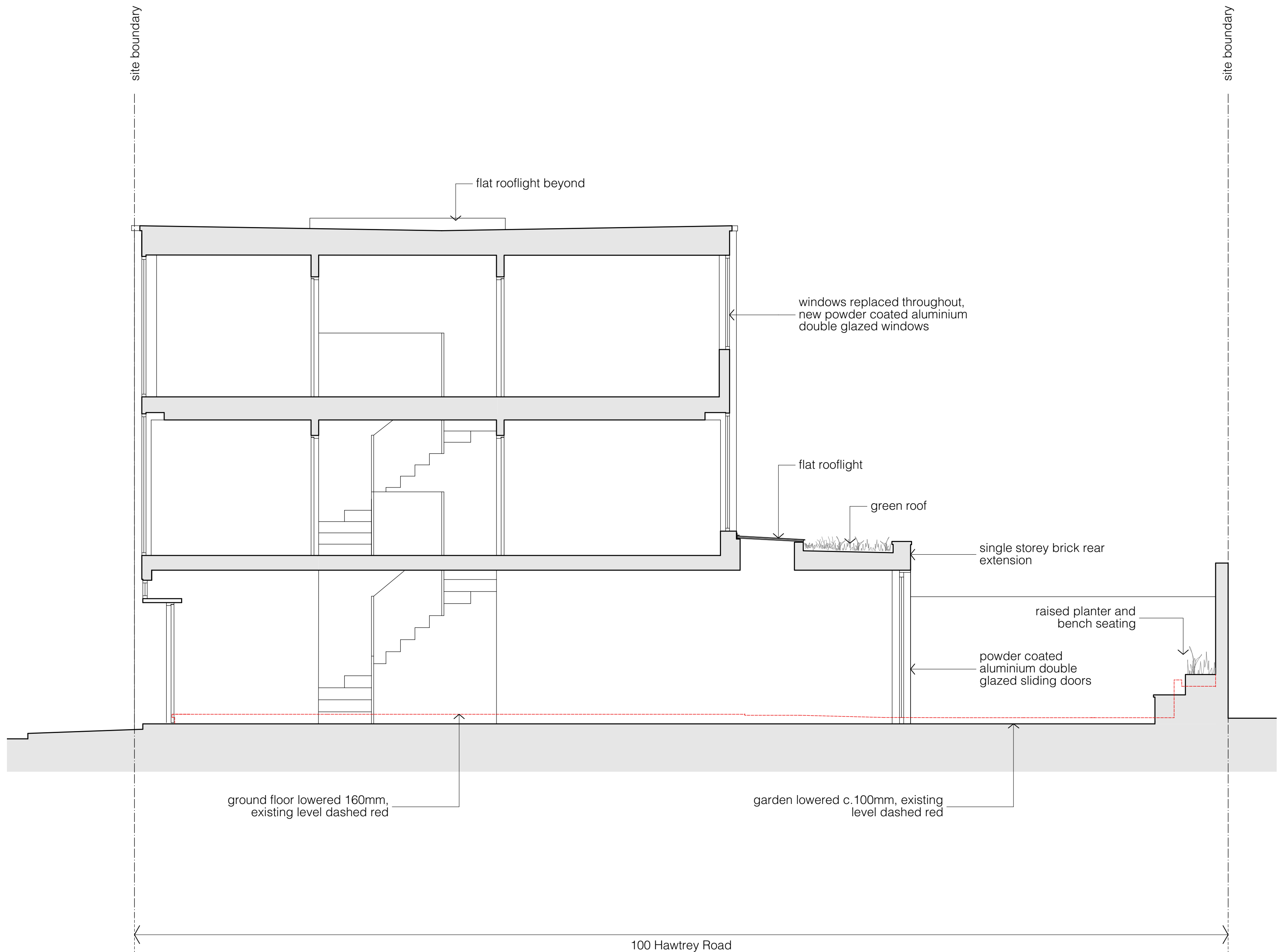
