
#### 4. Draft Statement of Common Ground.

A copy of the Developer's Notice served on the relevant Highway Authority as landowner is submitted. The notice was served on London Borough of Camden and on TFL (where applicable) on 3<sup>rd</sup> November 2018.

The Appellant requests as per discussions with PINS that the Appeal is heard by the Informal Hearing procedure. This appeal is part of a large number of submissions for prior approval that have been submitted to enable the applicant to provide a new telecommunications network. Having sought the advice of Leading Counsel, and applying the Inspectorate's procedural guidance (Annex K), the need to make legal submissions and the need to ensure all the relevant main issues about the correct approach to take, both put the appeals firmly within the category of appeals which would most appropriately be dealt with in a hearing and provide the best opportunity to deal with the large number of appeals submitted in the most efficient way possible.
