Informative(s):

1 This application relates to the installation of two ventilation panels to the rear elevation of the Grade II\* Bedford Way building designed by Sir Denys Lasdun.

The proposal involves the replacement of the glass to two top sashes on the rear elevation facing the service road. Once the glass has been removed powder coated ventilation louvres are to be installed within the retained window frame. The ventilation grills are to be located on the first floor and set adjacent to the concrete stair tower. There are coloured to match the existing glass elevation and as such are not considered to exert negative visual impact on the character or appearance of the Listed Grade II\* building nor on the wider Bloomsbury Conservation Area.

This scheme is to bring fresh air to the first floor. The applicant has stated that currently there is lack of mechanical ventilation on the first floor and existing service risers cannot be utilised.

Similar ventilation grills have been granted listed building consent for installation on the northern part of this Grade II\* building on 20 Bedford Way.

No comments have been recieved as a result of the public consultation through a Press Notice and a Site Notice.

Historic England responded with a letter of flexible authorisation duly stamped and signed on behalf of the Secretary of State.

The site's planning history has been taken into account when making this decision

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.
