Lombardy Poplar T1 (25M high, 1000mm dia.) - Remove all lower epicormic growth from stem and main limbs plus any low branches, up to 6 metres above surrounding ground level to achieve a balanced crown lift. Reduce lower 50% of the crown by up to 1.5 metres all around, where required, to achieve a balanced and well shaped tree. Crown clean.

Lombardy Poplar T2 (25M high, 1000mm dia.) - Remove all lower epicormic growth from stem and main limbs plus any low branches, up to 6 metres above surrounding ground level to achieve a balanced crown lift. Reduce lower 50% of the crown by up to 1.5 metres all around, where required, to achieve a balanced and well shaped tree. Crown clean.

Lombardy Poplar T3 (25M high, 1000mm dia.) - Remove all lower epicormic growth from stem and main limbs plus any low branches, up to 6 metres above surrounding ground level to achieve a balanced crown lift. Reduce lower 50% of the crown by up to 1.5 metres all around, where required, to achieve a balanced and well shaped tree. Crown clean.

Reason: The 3 trees are large and tall growing close to the buildings of Wellside and Coach House. The proposed works are to reduce overall size of the trees in relation to the close proximity of these buildings and to provide a minimum of 3 metres clearance from roof and building walls.
