Rear Garden:

- T1: Purple Plum: Reduce crown by approximately 20%.
 - T2: Magnolia: Reduce extraneous branches (approximately 10-15%) back into main crown structure to tidy.
 - S1: Shrub Juniper: Reduce by approximately 20% to control encroachment over lawn.
 - T3: Sequoia - (right hand side of main lawn): Remove dead wood only.
 - T4: Yew: Tip prune by approximately 0.75-1.00m.
 - T5: Sequoia: Remove dead wood only.
 - T6: Juniper: Remove major dead wood as is practicable.
 - T7: Apple: Reduce crown height by 20-25%. Reduce crown spread by 15% to balance.
 - T8: Ornamental Pear: Trim to tidy and reduce crown by approximately 20%.
 - T9 & T10: 2 x Thuja (forming one crown): Remove major dead wood as is practicable.
 - T11: Yew: Tip prune back from the path by 20% to help control encroachment, shape and balance.
 - T12: Irish Yew: Tip prune to promote a more compact crown structure (not more than 20%).
 - T13: Small Hazel: Reduce crown by 15-20%. Lightly trim lvy to help control encroachment.
 - T14: Lilac: Thin crown density by 15%. Remove dead wood.
- Reasons: General maintenance unless otherwise specified.
