Front Garden:

Mature Cherry: Fell to as near to ground level as is practicable without disturbing the front wall. Grind stump to approximately 300mm below current ground level.

Reasons: The tree has major longitudinal decay in the main stem and shows poor vigour and is suffering a degree of crown dieback. Crown reduction would only serve to worsen the trees condition and exacerbate hazard potential. The tree poses an unreasonable amount of risk in this location. It is growing over public footway and road.
