The Council has considered your application and decided to grant permission.

1 Reasons for approval-

The four areas of 102 photovoltaic cells are appropriately located and designed so as not to be visible, or least very minimally so, above the parapet edges of the block. They will have no visual impact on the appearance of the block as

viewed from the public realm nor on its surroundings, given the panels' height, angle and location. The submitted data show that the PV panels will contribute to achieving the required CO2 reduction targets and will be adequately maintained annually. Accordingly the development will provide adequate onsite renewable energy facilities and are considered acceptable by the Council's Sustainability Officer.

The full impact of the proposed development has already been assessed. The proposed details would not have a harmful impact on the appearance of the host buildings and streetscene or on neighbouring amenity.

As such, the proposed details are in general accordance with policy CS13 of the London Borough of Camden Local Development Framework Core Strategy and policy DP22 of the London Borough of Camden Local Development Framework Development Policies.
