Proposed Work:

REAR GARDEN: 1 x Purple Plum (T1) - Reduce crown by approx. 20%.
1 x Magnolia (T2) - Reduce extraneous branches (approximately 10-15%) back into main crown structure to tidy.
1 x Shrub Juniper (S1) - Reduce by approx. 20% to control encroachment over lawn.
1 x Yew (T4) - Tip prune by approx. 0.75 - 1m.
1 x Apple (T7) - Reduce crown height by 20-25% and reduce crown spread by 15% to balance.
1 x Ornamental Pear (T8) - Trim to tidy and reduce crown by approx. 20%.
1 x Yew (T11) - Tip prune back from the path by 20% to help control encroachment, shape

and balance. 1 x Irish Yew (T12) - Tip prune to promote a more compact crown structure (not more than 20%).

1 x Small Hazel (T13) - Reduce crown by 15-20%. Lightly trim Ivy to help control encroachment.

1 x Lilac (T14) - Thin crown density by 15%.
