- Completely remove all ivy growth on the right hand tree as viewed from the garden, small network of growth will need to be left to prevent bark scorch.

On both trees 1m strip round the base of the tree will need to be completely removed to ensure no regrowth takes place

T3 - Large Bay - Reduce height by 1m and reshape

Front Garden with Open Access

T4 - Mature Magnolia - Remove deadwood only
