e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

A pendulous copper beach tree. Situated at the front of the property of 157 West End lane. This tree is next to an inspection chamber which is 5 meters deep. The inspection chamber serves the foul waste sewage for the property. The pipework inside the bottom of the chamber has collapsed and the inspection chambers structure is falling away and is about to collapse also. This is resulting in foul sewage backing up and flooding out in the back garden of the property and is causing issues with flooding inside and outside of the property. Without excavating the pipework and chamber and rebuilding the chamber up from the pipework at a depth of 5 meters the sewage will continue to flood. With the excavation being so deep and 5 meter square hole has to be dug around the inspection chamber. This is causing us a massive issue as the trees proximity is so close to the chamber and requires removing from ground to carry out these extremely necessary and emergency works. We will do whatever is need to replant a new tree, if that is the case and are happy to plant any tree species that is required.
