I am writing to object to the above planning application.

The reasons for my objection are as follows:

1. The New College of Humanities (NCH) have been entirely disingenuous. Their application suggests that they are a small, Camden based business that wishes to relocate within the Borough. This is not the case. NCH have merged with Northeastern University which is a for-profit, US based institution with 26,000 students, 600 of which are already located in London and the intention is to expand this campus with over 1,200 students. This number of students would entirely change the character of the area, which is tranquil on the weekends and evenings. The residential and commercial communities sit happily side-by-side during the working week: this balance would be undermined by a large, transient student population who are highly unlikely to have the same care and respect for the Square.

2. This number of students is entirely inappropriate for a Conservation Area. Fitzroy Square was designed by the architect Robert Adam, developed in the 18th Century and intended to be the heart of Fitzrovia. It is an historic London square of extreme importance and university use it entirely inappropriate. Both Historic England and Camden recognise, in their policies, that it is essential areas of such historic significance are maintained and preserved.

3. The setting of the Listed Building is not appropriate for university use. There will be a large number of students coming and going creating noise, increased traffic and requirements for general servicing, all of which are not acceptable for an environment that is predominantly residential in character with some small scale office uses.

4. Camden's policy is that employment uses should be protected. The change of use to education would surely be contrary to policy? The Square already provides good quality office accommodation which is in demand. It is disingenuous to suggest that there is no demand for this type of accommodation – particularly at a time when there is a known shortage of office accommodation across London.

There are strong planning grounds for refusal and it is essential that Camden consider these thoroughly and direct this application for refusal.
