e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 - sycamore tree - remove 2 lowest branches and thin by 20%.

T2 - holm oak tree (TPO, neighbour's) - lift overhanging branches to 6m from ground level and reduce overhanging half of crown up to 1.5m. The tree is causing excessive shading to the garden.

T3 - yew tree - cut overhanging branches back to boundary.

T4 - crab apple tree - cut overhanging branches back to boundary.
