We have two dead trees in our backyard which after evaluation from tree surgeon (Roman Trees) need immediate removal as they are both about to fall down. Tree species

-- Tree 1: Purple plum -- Tree 3: Pine

- Description of the proposed works: for both trees - fell to ground level by sectional take down.

Both trees are completely dead and the stem is completely rotten - high risk of trees falling over. We are planning to plant some Camellias next to the summer house to replace the dead plum and pine trees.
