The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

- 1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.
  - Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).
- The development hereby permitted shall be carried out in accordance with the following approved plans: MTH\_CD\_001, MTH\_CD\_002, MTH\_CD\_003,

MTH\_CD\_004, MTH\_CD\_005, MTH\_CD\_006.

## Reason:

For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

## Informative(s):

Reasons for granting permission.

The entrance doors will replace a non-original glazed door within an existing opening of the building. The simple, curved glass design will not appear overly dominant to the overall character or appearance of the host building, and will not adversely affect the special architectural characteristics for which it is locally listed. The development is considered to be minor in scale, and the doors will appear as a modern intervention that will not harm the overall appearance of the building or the wider street scene.

The development will not affect the existing level access to the building, and the original opening width of 1830mm is maintained to provide accessibility for wheelchair users. The doors slide open within the building envelope and will therefore not impinge on the public highway. By virtue of the nature of the development, it will have no impact on residential amenity with respect to loss of privacy, light or outlook.

No objections were received prior to making this decision. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017. The proposal also accords with the London Plan 2016 and the National Planning Policy Framework 2019.
