The Council has considered your application and decided to grant Approval of Details (Listed Building) subject to the following condition(s):

Conditions And Reasons:

The works hereby permitted shall be begun not later than the end of three years from the date of this consent.

Reason: In order to comply with the provisions of Section 18 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

The development hereby permitted shall be carried out in accordance with the following approved plans: 301-501C; 301-502; 301-503D; 301-504C; 301-505.

Reason: In order to safeguard the special architectural and historic interest of

the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

3 All new work and work of making good shall be carried out to match the existing adjacent work as closely as possible in materials and detailed execution.

Reason: In order to safeguard the special architectural and historic interest of the building in accordance with the requirements of policy D2 of the Camden Local Plan 2017.

Informative(s):

1 This application is for the approval of the following:

Condition 4a (new doors): Details of the new doors have been submitted. Both doors are traditional four panelled timber doors. These are considered sympathetic to the age and character of the building. The door architraves will be ogee moulding, which respects the First Floor status within the building.

Condition 4b (new fireplace): Details of the new fireplace have been submitted. The fireplace will match the existing fireplace on the chimney breast on the opposite side of the Drawing Room. It will be marble with a cast iron inner fire surround and fire grate. This is considered acceptable.

Condition 4c (new opening in chimney breast): Proposals involve the removal of non-original infill brickwork to a chimney breast in the Drawing Room at First Floor level. The works are not considered to cause harm to the special interest of the listed building.

Consultation was not required for this application, and no objections were received prior to making this decision. The site's planning history has been taken into account when making this decision.

Special regard has been attached to the desirability of preserving the listed building and its features of special architectural or historic interest, under s.16 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with policies D1 and D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the National Planning Policy Framework.
