Proposal:

Replacement of single glazed steel framed windows and doors at ground floor level along front elevation with new double glazed aluminium framed windows and doors.

Drawing Nos: (1115-10-)100 rev A, 101, 302 rev A; 1115-12-300.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

The development hereby permitted shall be carried out in accordance with the following approved plans: (1115-10-)100 rev A, 101, 302 rev A; 1115-12-300.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting planning permission:

The proposed replacement front elevation double glazed aluminium framed windows and doors will match as closely as possible the existing windows and doors in terms of their design, frame sizes, opening methods and proportions.

The increase in thickness to the glazing bars/frames in order to accommodate the double glazed panes is minimal. The use of suitably designed, slim profile window units is considered to be appropriate. The alteration in materials and colour from white steel to black aluminium and the alterations in glazing pattern is also considered to be sensitive and appropriate in the context of this building. They would not detract from the character and appearance of the building or wider South Hampstead Conservation Area, and as such, would be acceptable.

The proposal would also provide environmental and sustainability benefits in accordance with Council aims and objectives through increased thermal resistance and a reduction in the transfer of heat, so improving long-term energy efficiency and performance within the building.

There would be no loss of amenity in terms of overlooking to neighbouring properties, given the fact that the proposal would replace existing windows and doors.

The site's planning and appeals history has been taken into account when coming to this decision. No objections have been received following statutory consultation.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the South Hampstead Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017, the London Plan 2016, and the National Planning Policy Framework 2019.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings. Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974.
