a) Plan, elevation and section drawings of all new windows and doors, balconies and gate at a scale of 1:10 including jambs, head and cill of the new window and door openings.

The relevant part of the works shall not be carried out otherwise than in accordance with the details thus approved.

While the internal layouts were amended in the interest of desirability of the residential units and to comply with the Code for Sustainable Homes, the external aspect of the building remains unchanged.

A sample panel of all facing materials and means of enclosure should be erected on-site and approved by the Council before the relevant parts of the work are commenced and the development shall be carried out in accordance with the approval given. The samples must include a 1m² facing brickwork panel demonstrating the proposed colour, texture, face-bond and pointing.

Supporting narrative

Sample panels of all facing materials and means of enclosure will be erected on site before the relevant parts of works will be undertaken, for approval by the Council in due course, as stipulated by the condition.

Included in this application is a brick sample of the type Smeed Dean London Stock for the bricks to be used on the development, to be delivered to your office.

A 1 m² brick sample panel will be ready for you to view on site as and when requested.
