Firstly, Materials By Rail (MBR) should be the only option available for this project. I understand that HS2 will use MBR only from the Euston Station site, and not in the Cutting, because of financial costs. This decision is outrageous as it denigrates and dismisses the genuine concerns of residents who have already had to contend with years of significant disruption and impact on their lives. By refusing to use MBR, HS2 is sending a clear signal to all residents that our lives, our health, our safety, our environment, our physical and mental well-being, our quality of life and our living conditions are of zero importance. I object to the contempt and disdain with which HS2 conducts itself in relation to the human cost of this flawed and irresponsible project.

Notwithstanding my principle point, I would also urge the committee to consider the following:

HS2 should not be using residential roads in densely populated residential areas to run lorries to and from their worksites. Main roads should be the only option. The main worksite is next to Hampstead Road so create an entrance onto Hampstead Road directly from there.

HS2 should not remove road humps which are safety measures for the many thousands of people who live on the estate. In particular, children and young people, elderly, disable and cyclists will be more vulnerable and the risk of 'accidents' will increase. Does HS2 really need to see someone killed as a result of their presence in the area before they acknowledge the increased danger of this project?

HS2 should not even contemplate the removal of what is currently an illegal turn (right onto Hampstead Road from Robert Street) on the basis that it's easier for them. Residents safety should be paramount in the minds of the committee members.

Other impacts

Pollution: our area already suffers from pollution, it is the nature of an inner city with too much traffic. Camden should be putting in measures to reduce vehicles in the area, not increase them. Irrespective of how 'green' or low emission the HGVs may be, this will still increase the pollution levels in the area. This is an unacceptable risk to our health and our precious environment.

Safety: there are schools directly impacted. Children, young people, all at increased risk because of danger HGVs pose. Sitting high up in a cab restricts view the driver has. As a cyclist (as are my husband and child), I am also personally at increased risk. My teenage child, like many others in the area, walks to her school which is not in the immediate area. Footfall in the area is high, particularly between 8:00 and 9:00. The numbers indicated mean at least two HGVs every single minute – imagine the congestion this will cause. Residential streets are no place for HGVs and we have a right to live in safety.

Well-being: this applies both physically and mentally. The noise, pollution, safety issue and our quality of life will be diminished significantly. HS2 has no right to impose such impacts on us as a cost-saving measure.

Access to information: I only became aware of this proposal this week as a neighbour told me about it. HS2 sends out information to residents by post, usually about waterworks and road closures. At no point have I seen anything to alert residents to this. This proposal has significant impacts, but few residents are aware of it.
