e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sycamore x 3 (T1, T2, T3) – Reduce crowns back to previous reduction points. Particularly reduce the branches over the neighbour's roof, by up to 1.5m. Ash (T4) – Reduce crown back to previous most recent cuts. The trees are under cyclical pruning. They block light and are close to the house so need pruning to restrict root growth and allow more light into the garden.
