Full Planning Permission Granted

Address: Flat B 26 Healey Street London NW1 8SR

Proposal:

Formation of first floor roof terrace over existing rear extension with associated timber balustrade.

Drawing Nos: OS Location Plan, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, FIG 1, FIG 2.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

2 All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 of the London Borough of Camden Local Plan 2017.

3 The development hereby permitted shall be carried out in accordance with the following approved plans: OS Location Plan, 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, FIG 1, FIG 2.

Reason: For the avoidance of doubt and in the interest of proper planning.

Informative(s):

1 Reasons for granting permission

There is a precedent for roof terraces at the rear of properties on Healey Street and Hadley road, and these comprise lightweight balustrades such as decorative fences, timber trellises and mesh fencing. The proposed timber trellis is in keeping with the immediate site context and preserves the character and appearance of the host building and the existing townscape.

The terrace does not exacerbate current levels of overlooking at the site, over and above that which is currently experienced by virtue of views from the rear kitchen window. Furthermore, the proposed trellis would obscure any oblique views to adjoing windows in the terrace. As such, it is considered that the development does not have any significant impact on neighbouring residential amenity.

The Kentish Town Neighbourhood Forum did not wish to comment as the site is not within the Neighbourhood Plan area. The occupant of no.2 commented that the terrace could be overlooked by other properties, could cause water ingress to the property and that metal railings would be more secure. None of these matters are material reasons to refuse the development. No objections were received prior to making this decision. The site's planning history and relevant appeal decisions were taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1 and D1 of the Camden Local Plan 2017. The proposal also accords with the London Plan 2016 and the National Planning Policy Framework 2019.
