History

The building was originally occupied by Arup Group Ltd on a lease that expired 28th February 2019. Arup Group sublet the building as follows:

- i. Wimberly Allison Tong & Goo (UK) Limited (WATG), a firm of architects, occupying the lower ground, ground and first floors (approx. 13,450 sq. ft) from Dec. 2011 to Feb. 2019.
- ii. University College London, on a lease over the 2nd and 3rd floors (approx. 7,500 sq. ft) from June 2014 to February 2019

WATG found the space too much and relocated to approx 6,000 sq. ft at Seven Dials Warehouse 42 Earlham Street London WC2H 9LA in January 2019.

The University College London also decided they wanted to leave and vacated on their lease expiry.

Marketing Record

The building was first put on the market around May 2017 with a view to identifying a new occupier prior to the lease expiries in Jan 2019.

Despite a great number of viewings as outlined on the attached schedule (51 viewing entities listed see below). All potential lessees required short leases of 3 or 5 years, which is an ongoing market feature due to various reasons including economic and political uncertainties.

This made the building commercially unviable for the freeholder or potential tenant, as neither wanted to outlay for the required air conditioning and refurbishment/fitting out. Therefore, the only viable solution was a long lease, but market conditions made this extremely difficult.

The Dutch Embassy agreed terms for a new deal in March 2019 however after further due diligence the deal proved abortive and legal documents were returned in May 2019.

Owing to the severe scarcity of D1 Education situations across London, Northeastern University, Boston US (NU) are willing to undertake the works required and to commit for a long term lease over the premises once it has achieved a D1 Use.

NU first made a proposal for the building in February 2019 but were unable to pursue further due to interest from the Dutch Embassy. Once the Dutch Embassy deal failed we reverted to the building and agreed revised terms in June 2019, subject to achieving the D1 Education Use.

As the building has a Grade 1 listing, no business rates are payable over the property whilst vacant.

The owner of Boston House also owns the neighbouring property County House which currently has a D1 Education Use over approx. 10,000 sq. ft. The lease over that building will expire in 2022 and the landlord will undertake to return the D1 accommodation to B1 Use on its lease expiry should that assist with the granting of the D1 Use over Boston House.
