we have just seen the planning application (tied onto a lamp post). We are amazed that we were not consulted about this application before now as the building work will detrimentally affect our property. In the Rok Planning Letter 9 in the conclusion it says lit has been demonstrated that the proposals are unlikely to affect the privacy and amenity of the adjoining occupiers as per local policity A1.1 THIS IS NOT TRUE. THE BUILDING WILL AFFECT OUR PRIVACY.

We now find that we have to reply to you by 11 November 2019 d 3 days time

The development will turn our house - which is at present a detached house into a semi detached house. Secondly we bought what we considered to be a unique architect designed house and now find that the style and design is to be copied by the house next door.

We think that the proposed new two story infill house should be set further back, so that it is differentiated from our house. This will allow for the parapet from our roof terrace and the wrap around of timber of our wall to be retained. Otherwise it would seem we would be forced to remove both.

Disturbance During Building Works

Study by Delva Patman Redler does not take 26 Anglers Lane into consideration

I do not understand why the Study by Delva Patman Redier Ref no 1938 does not mention 26 Anglers Lane in any of the tables. Our roof terrace (which was specifically allowed to give us a garden space) may be affected by light issues. Whilst other buildings are taken into account, ours is not (see point 4.0 Table 1 and point 8.1
