We (Ms Violet Oruwari-McCabe an Interested Resident with a PSLtd Law Firm) are in support of this planning application for the conversion of a section of the Ludham Estate Garages (Undercroft); as the related documents attached confirm the proposed area for the extension to the London School of Mosaic (LSoM) will be predominately act as a further introduction to the place (potential facilities in the area and LSoM), but above all, also as a community forum for residents and other local people, which will provide the opportunity for community cohesion projects to start up here, remain and thrive.

We (PSLtd a law firm) believe we need investment in the area and we agree the Ludham Undercroft Development project may be the start of what is needed here; so we are starting the development of our FREE Legal Advice Surgery at the LSoM with Barrington Court TRA, CAV and others; ready to roll this much needed Access to Justice out for the immediate community, and to take a. We want to work with these and many more other groups in this community. Like other positive members of this community, we do not want to replicate the territorial wars that has an area terrified with no hope because just as the drugs and violent weapons are barriers to the spirit of community cohesion; criticism that is not purely constructive and are poison arrows in disguise, merely to undermine projects we do not lead or control, has the similar destructive disunifying impacts to community spirits too.

We therefore agree with other positively progressive residents of the immediate community, who believe this project " ... looks really exciting ...," and we hope with them that an extension to the existing school " ... would certainly give a New Lease of life to this gloomy space ...," turning " ... a horrible area into a positive more [joy filled] place ... !" We all need to remember many of us have still been working hard for free to make changes, particularly since all the violence has been escalating to regular deaths of our youth. A lot of voluntary projects started on the back of public meetings for our lost youth for those still with us; and they need a space to set-up and/or develop to thrive, which is what the LSoM Ludham Undercroft Development project will hopefully be offering.

Furthermore, it is because this is a quiet residential closed off community with many young families and elderly people isolated, without easy immediate access to helpful required opportunities, and stimulating activities; that we consider the project to be positive progress in a hopeful direction. It is therefore quite right to start community focused businesses out of this very dead problematic space (it's in the history) - especially those that offer many different sessions in each day throughout the week for accessibility to much wider demographics in our community. This is more likely to lead to positive constant footfall and engagement around this area. In fact, the Met Police Response dated 18.10.2019 (submitted to Planning on 23.10.19), actually stated this would be more likely to act as a natural surveillance – factors that improve security and reduce crime. This is also along with projecting being a " … Huge help with solving the refuse bin areas and overspill of rubbish on the garden areas," being another Resident Comment.

We however do not agree with the Added Comment, that it would really be such a good idea to make the whole basement garage space into a larger LSoM with just more artist studios. This is because we believe (and as stated in the Application) " ... the mix of facilities proposed for the extension site will allow the existing site of the LSoM to become a dedicated school and teaching area." Furthermore, the existing LSoM may already have sufficient space to develop the school; so we believe the proposed extension to it will only be to support the on-going training of artists and crafts people by providing affordable workspaces for recent graduates.

				It is noted that the concerns surrounding the project's planning application appear to be simply because LSoM will be getting a New Lease to expand in that location; and it sits alongside the pre-existing (10-40 years) issues between the Council and Residents. In total there are four refuse collection points within the full Ludham Undercroft with a total of 24, and the LSoM in consultation with the Residents, the Council and other interested parties appear to have provided several realistic solutions that should be properly reviewed and considered.	
				Nevertheless, as a local Resident (and Pillar of the community) indicated – it is a problem for the Council to resolve with the Residents and Veola (refuse collectors) being more reasonable; so, we say it is not an issue caused by the LSoM Application and connected projects. Consultation must, and has been done by Camden Council with the residents in order to finalise locations, and we note this closed on 5th November 2019.	
				It should also be noted that having been in residence within a portion of the basement Undercroft (680sqm) since 2017 " the school is a centre of excellence for mosaic making, providing many courses on all aspects of mosaic making at all levels. It is a very inclusive organisation. It has become an important resource in the local community. Adults and children have the opportunity to participate in mosaic projects. All are welcome and every effort is made to meet the needs of every individual. This will put to good use space which has been derelict for at least the last 20 years since I have lived here and will offer an opportunity to resolve the long standing issue of inappropriate rubbish and recycling facilities on the estate. In particular, the small rubbish chutes which were installed previously in place of one of the Ludham bin chambers in order to create an emergency exit for the undercroft area by the previous occupants before the London School of Mosaic have been a disaster. They are too small for the family flats who need to use them and are not fit for purpose. They have now become a constant source of fly tipping and lead to increased work for the already over-stretched caretaking service. There are, however, some issues which will need to be resolved before the proposed development can go ahead: Firstly, the water supply for the caretaker to clean the communal areas of Ludham is currently housed in the bin chambers and would need to be some reassurance that there would be no disturbance to residents caused by any of the businesses using the space. Lastly, the existing rubbish facilities underneath Ludham would need to be moved and it is important that the fly tipping is not just moved to another location creating problems elsewhere. One of the locations suggested borders Southampton Road and, when there were previously recycling bins there, it led to vehicles pulling up and fly tipping there as it was visible from the road. The new location must be workable for the residents of Ludham as well as the caretaker and Veolia who currently hold the contract for removing waste. The rubbish and recycling facilities at all for the residents of Ludham which is a disgrace. I believe that the Council departments should be looking at this and not leaving it to an outside organisation such as the London School of Mosaic has worked hard to engage the local community and

As I member of the TRA, I must however stress that residents in Ludham and Waxham should be consulted on the proposals, in particular on the arrangements for rubbish collection. For over 20 years there has been an issue with rubbish collection for Ludham (and for Waxham) which has not been resolved. Whilst supporting this application it is critical that this issue is resolved satisfactorily for residents, albeit some compromise may need to be reached. I would not want this issue to be a stumbling block in bringing a positive development for the estate. On a point of accuracy, this application is listed under Tobin Close NW3 which is incorrect and has probably lead to a comment against the scheme based on this error. In addition Ludham has been incorrectly spelt.
