# Informative(s):

1 Reason for granting listed building consent:

27 Mornington Terrace forms part of a long stock brick mid-19th Century terrace, Grade II listed and situated in the Camden Town Conservation Area. The Camden Town Conservation Area can be divided into two sub areas of distinctly different character, a busy commercial and retail area, and, a quieter more formal residential area. The application seeks to demolish and rebuild the existing 1.35m high 225mm thick walls dividing the rear gardens of the two properties either side of No 27 due to continuing structural damage and varies from approved application refs 2018/2353/L and 2018/2354/P to allow the omission of the section of wall abutting the adjacent outbuilding, replacing it with a timber close boarded fence. The new walls will be rebuilt from brickwork salvaged from the demolition of the existing wall. New brickwork will be stock bricks laid in Flemish bond in a mortar mix to match the existing wall.

The proposed works will not harm the special interest of the grade-II-listed building.

The application has been advertised in the press and by means of a site notice, whereby there were no consultation responses. The site's planning history has been taken into account in making this decision.

Special attention has been paid to the desirability of preserving the special interest of the listed building, under s.16 of the Listed Buildings and Conservation Areas Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013

As such, the proposal is in general accordance with Policy D2 of the Camden Local Plan 2017. The proposed development also accords with the London Plan 2016 and the NPPF.
