Reduce the lateral and sub lateral branches by approximately 2.50m in order to form a more compact crown structure without greatly affecting crown height. Raise crown on the right hand side of the tree when viewed from the street by approximately 1.00m to balance. Tidy past poor pruning wounds. Reduce the rear section of the tree back to clear the building by approximately 4.00m. Install flying falcon bird scarer
