

#### 1.0 Introduction

#### 1.1 General

- 1.1.1 This Design and Access Statement has been prepared by Baily Garner on behalf of Clarion Housing Group. It accompanies the full planning application for the removal of existing single-glazed timber windows / doors to the property and replacement with like for like timber double glazed windows / doors to the all elevations of the property.
- 1.1.2 This report responds to the requirements of the Town and Country Planning (General Development Procedure) (Amendment) (England) Order 2006 (the GDPO) for planning applications (with some exceptions) to be accompanied by a Design and Access Statement.
- 1.1.3 The structure and content of the statement has been informed by DCLG Circular 01/2006 Guidance on Changes to the Development Control System (12 June 2006) and Design and Access Statements: How to Write, Read and Use Them (CABE, 2007). Together these have provided advice on what a Design and Access Statement should include.

## 2.0 Understanding the Context

#### 2.1 Site Description

- 2.1.1 17 South Villas is a converted house consisting of 4no flats. 1-4, 17 south villas is a four storey property constructed traditionally with a decorated render finishes to the front elevation; it is assumed this elevation is of solid brickwork. Both the flats at the rear elevations are a brown/grey solid wall construction. From basement level to the 1<sup>st</sup> floor level there is a render finish to the part of the rear with a pitched roof.
- 2.1.2 Existing rainwater goods are a mixture of PVC-u half round profile attached to PVC-u downpipes. Soffits and fascia attached boards appear to be timber with a distinctive finish black.
- 2.1.3 Access to the flat 2-4 is via a single main entrance door located on to the front elevation above ground level with steps leading to this communal door. Flat 1 (basement) is accessed via a staircase leading to this flat door.
- 2.1.4 The existing windows are a mix of style glazed hung timber casements and single glazed timber sliding sash windows.
- 2.1.5 To the rear of the property is a communal garden which is accessed from the ground floor flat and basement property.

## 3.0 **Design**

### 3.1 Description of the Proposal

- 3.1.1 The works include the removal of existing of existing single-glazed timber windows / doors to the property and replacement with like for like timber double glazed windows / doors to the all elevations of the property. The proposal is to replace all existing timber windows / doors within the property.
- 3.2 Use
- 3.2.1 The property is a converted house of four storeys, serving 4no. dwellings via one main entrance, and a separate entrance to the basement flat.
- 3.2.2 The property is not listed, nor is it not located within a Conservation Area.
- 3.3 Layout
- 3.3.1 No alterations required to the existing layout of any dwelling.
- 3.4 Scale
- 3.4.1 No change in scale is proposed and therefore this item is not considered applicable.
- 3.5 Appearance
- 3.5.1 It is proposed that the fenestration of the new windows will be as close to like-for-like replacement to match the existing style and colour of the previous windows and be in keeping with the area.
- 4.0 Access
- 4.1.1 No changes to access are proposed and therefore access is considered not applicable.

- 5.1.1 The removal of existing of existing single-glazed timber windows / doors to the property and replacement with like for like timber double glazed windows / doors to the all elevations of the property. The proposal is to replace all existing timber windows / doors within the property. All windows are to match the existing timber window / doors fenestration.
